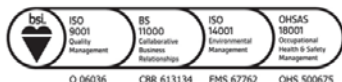

#### In the event of splashes or contact with skin :

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.

Watch out for any remaining product between skin and clothing, watches, shoes, etc.

In the event of an allergic reaction, seek medical attention.

If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

Wash thoroughly with water and soap.

#### In the event of swallowing :

Do not give the patient anything orally.

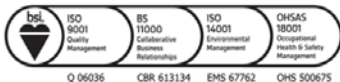
In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor.

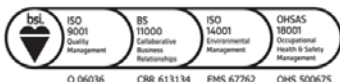

Suitable type of protective clothing :

In the event of substantial spatter, wear liquid-tight protective clothing against chemical risks (type 3) in accordance with EN14605 to prevent skin contact.

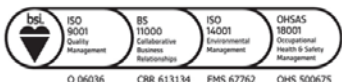

**SECTION 11 : TOXICOLOGICAL INFORMATION****11.1. Information on toxicological effects**

Exposure to vapours from solvents in the mixture in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on kidney, liver and central nervous system.

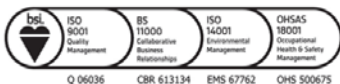

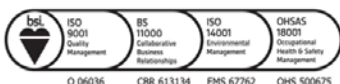
