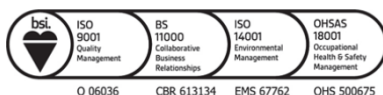

**SECTION 4 : FIRST AID MEASURES**

If swallowed accidentally, call a doctor to ascertain whether observation and hospital care will be necessary. Show the label.
